Collection of Drug-involved Crash Data


- Drug involvement is likely underreported by officers
 - DUI can be for alcohol OR drugs
 - easier for officers to prove impairment by alcohol
- Data source is not a survey or driver reported
 - crash reports from law enforcement
 - supplemented with drug and alcohol test results (crash-related fatalities only)
 - drug type is not collected on the crash report

Cannabis-specific data

- Only collected for <u>crash-related</u> <u>fatalities</u>
- People killed in crashes with a blood alcohol content (BAC) above 0.08g/dL generally do not undergo drug testing
- Drug testing for fatalities expanded in 2018 (limited historical data)
- "Cannabis-involved" doesn't necessarily mean "Impaired"


Cannabis-involved - a fatality that tested positive for cannabis. Not a measure of impairment. Sources: NMDOT Crash Database and NMDOT Fatallog File, 2018-2022. Preliminary 2022. Drug testing reported by OMI. Database only contains reportable crashes: crashes on a public roadway with a fatality, injury or greater than \$500 in damages.

Overview of Drug-involved Crashes




Drug-involved Crash – a crash where the officer selected "Under the Influence of Drugs or Medication", "Sobriety - Consumed a Controlled Substance", or "Sobriety - Consumed Medication" on the Uniform Crash Report for any motor vehicle driver, pedestrian or pedalcycle operator.

Overview of Drug-involved Fatalities by Drug Type




Drug-involved - a fatality who tested drug-positive. Not a measure of impairment. Stimulants: cocaine, meth Narcotics: opioids, heroin, oxycodone, fentanyl

Cannabis-involved Motor Vehicle Driver Fatalities




Cannabis-involved - a fatality that tested positive for cannabis. Not a measure of impairment.

Cannabis-involved Non-Motorist Drivers (Pedestrians and Pedalcycle Operators)




Cannabis-involved - a fatality that tested positive for cannabis. Not a measure of impairment.

Cannabis Involvement and Alcohol Impairment




Cannabis-involved – a crash-related fatality that tested drug-positive. Not a measure of impairment. Alcohol-Impaired - a fatality with a BAC of 0.08 or higher (0.02+ for fatalities under age 21, 0.04+ for heavy truck drivers).

Legalization of Cannabis for Recreational Use: Before and After Trends




Driver and Non-Motorist Behaviors




Improper driving: primarily other improper driving, drove left of center, and failure to yield.

Age and Sex




Vehicle Type




These are vehicle types that showed an increase in cannabis involvement

Victims



"Victims" are people in crashes that involved a cannabis-involved driver or non-motorist fatality except the cannabis-involved driver/non-motorist fatality.
